CHARTER TOWNSHIP OF VAN BUREN REGULAR BOARD MEETING MINUTES MARCH 15, 2011

Supervisor White called the meeting to order at 7:30 p.m. in the Board Room. Present: Supervisor White, Treasurer Budd, Trustee Hart, Trustee Jahr, Trustee Ostrowski and Trustee Partridge. Supervisor White introduced Parks and Recreation Director Wright.

APPROVAL OF AGENDA: Budd moved, Ostrowski seconded to approve the agenda as amended. To postpone New Business items #2 "Consider extension of Planned Residential Development Agreement for Bedford Cove Subdivision." and #3 "Consider extension of the Final Preliminary Plat for Bedford Cove Subdivision." to the April 5, 2011 Board of Trustees Meeting. Carried.

APPROVAL OF CONSENT AGENDA: Hart moved, Partridge seconded to approve the consent agenda [Work Study Session Minutes February 28, 2011 and Regular Board Meeting Minutes March 1, 2011] as presented. Carried.

PUBLIC HEARING: None.

Chief Loyer announced the Fire Department will be hosting the Third Annual Citizens Fire Academy. The Citizens Fire Academy runs for nine weeks beginning on April 6th and applications are due by March 21st.

Jahr moved, Budd seconded to grant Special Use Approval for a 3.53 acre site located at 9700 Belleville Road for outdoor sales space for exclusive use of used, second-hand automobiles in accordance with Section 13.03b, Subsection 6 of the Van Buren Township Zoning Ordinance based upon the

recommendation of the Van Buren Township Planning Commission, the McKenna letter dated February 16, 2011 specifically incorporating all of the conditions, all of the conditions noted on the preliminary site plan approved by the Van Buren Township Planning Commission and with the additional notation that the site is to be used solely for the sale, display and storage of automobiles including light trucks and vans exclusively. Carried.

Budd moved, Hart seconded to approve to pay \$57,995.54 for the Winslow Drain Special Assessment to Wayne County, as requested; to move the funds from Undesignated Fund Balance to Board Other and not make the payment until the end of September 2011. Carried.
