CHARTER TOWNSHIP OF VAN BUREN BOARD MEETING MINUTES JULY 16, 2013

Supervisor Combs called the meeting to order at 7:00 p.m. in the Board Room. Present: Supervisor Combs, Clerk Wright, Treasurer Budd, Trustee Hart, Trustee Jahr, Trustee McClanahan and Trustee Miller. Absent: None. Others in attendance: Captain Laurain, Chief Besson, DPW Director Taylor, Deputy Supervisor LaMothe, Secretary Cline and an audience of sixty-two (62).

APPROVAL OF AGENDA: Jahr moved, Hart seconded to approve the agenda and the Consent Agenda [Work Study Session Minutes July 1, 2013; Regular Board Meeting Minutes July 2, 2013; Voucher List of July 16, 2013.] as presented. Carried.

PUBLIC HEARING: None.

CORRESPONDENCE: Van Buren Public School Board President Mikulski gave a brief presentation on the positive events in Van Buren Public School District including the following: classroom learning, finances, operations and communication. Superintendent Van Tassel discussed recent changes to improve the school district such as the redistricting of schools, new policies regarding discipline and bullying and noted the improvement in ACT scores this year.

Fire Chief Besson introduced the following six new Probationary Paid-on-Call Fire Fighters Ryan Smith, Dustin Cox, Kurt Driscoll, Stephen Jones, David Kail and Bronson Campbell.

Captain Laurain stated the recent "Coffee with a Cop" was successful with around 100 participants. A certificate of appreciation was presented to the owners of Leo's Coney Island.

Supervisor Combs read a thank you letter from Janet Campbell who attended the "Coffee with a Cop" event with her husband stating this was a wonderful idea.

Captain Laurain announced on Saturday, August 10th from 10:00 a.m. to 2:00 p.m. Van Buren Public Safety Day will be held at Walgreen's parking lot. Chief Besson stated the refurbished Fire House will also be at this event.

A letter from Ruth Bleeker regarding a plaque honoring former Supervisor Gollwitzer is missing from Van Buren Park and is seeking help to find out where it is.

Supervisor Combs read a letter from Hoosier Energy stating the Visteon/Hoosier Cogeneration plant project will not be built.

Jahr moved, Miller seconded to approve the Job Description for Department of Public Works (DPW) Superintendent; Personal Services Agreement between William Turner and Van Buren

Charter Township as DPW Superintendent and to authorize the Supervisor and Clerk to execute the Agreement. Carried.

Wright moved, McClanahan seconded to adopt <u>Resolution 2013-12</u>, purchase of land foreclosed on by Wayne County Treasurer. Roll Call Vote. Yeas: McClanahan, Jahr, Hart, Budd, Wright and Combs. Nays: Miller. Absent: None. Carried.

Wright moved, Hart seconded awarding contract to Tri-Star Roofing & Sheet Metal, LLC for repair, removal and replacement of specifically identified areas of the Township Hall not to exceed \$220,800 and to authorize the Supervisor and Clerk to execute the contract. Carried.

REPORTS: Supervisor Combs received and filed the May 2013 Budgetary Report.
