Vice Chairman Atchinson called the meeting to order at 5:30 p.m.

**REPORTS**: DDA Executive Director Ireland reported on the status of the Belleville Road/I-94 North Service Road sidewalks, walkability audit, electrical upgrades at the monument, Belleville/Ecorse Road intersection landscaping, regional detention pond, rights-of-way acquisition, emergency sirens installation proceeding, banners, Belleville Road properties and the Finance Sub Committee.

Executive Director Ireland shared that the official permit had been received from Wayne County for the sidewalk project and that bid opening is scheduled for April 15, 2015 in the Denton room at 10 a.m.

Executive Director Ireland requested that the DDA board explore the feasibility of obtaining a Business Credit Card for DDA usage with a nominal credit limit. Discussion was led by Vice Chair Atchinson. Baskin moved, seconded by Zoller to authorize Director Ireland to secure a Business Credit Card for DDA usage with a \$2000 monthly limit with Director Ireland and Assistant Director Lothringer as authorized signers. Motion carried.

Assistant Director Lothringer reported on the status of the DDA marketing campaign. Presented copies of the most recent Business of the Month e-Blast (released 3/2/15), DDA News e-Blast (released 3/16/15) and the DDA e-Newsletter (scheduled release 3/25/15). Informed the board that the April Business of the Month will be Feed Rite and that a photo shoot and interview has been completed.

Assistant Director Lothringer also advised the board of her activities to increase the DDA's presence within the community. She recently attended the Belleville SOUP Project, BACC meetings/events, and there has been positive feedback from the community regarding the email marketing campaign and Facebook posts.
