BACKGROUND – (SUPPORTING AND REFERENCE DATA, INCLUDE ATTACHMENTS)

In 2015, funds were approved by the VBT Board of Trustees and allocated to Parks and Recreation capital outlay in the amount of \$122,517. These funds were designated for park improvements including the demolition of the Riggs house. Due to unforeseen circumstances, the demolition did not take place in 2015 and is slated for spring of 2016.

The remainder of these funds, \$41,136.36, was not utilized in 2015 and it is the desire of the Parks Department to use these funds in 2016 to demolish the Riggs house and for other smaller park improvement projects.

These funds were originally obtained through MMRMA reimbursements. \$22,157 was obtained through an insurance claim when the Riggs barn burned down and \$100,000 was obtained through a MMRMA insurance refund.

BUDGET IMPLICATION
