#### APPROVAL OF AGENDA:

#### APPROVAL OF MINUTES:

#### **REPORTS:**

- 1. Monthly Operations Reports- Superintendent Ladd
  - a. October- November Activities
    - Sewer Items- Sanitary lift stations winterization and generator maintenance are being finished up. The new pump at the Beckley Lift station has been installed and UIS has calibrated all of the sewer meters for the Township.
    - Water Items- We are finishing up the winterizations of hydrants Township wide. The
      water main repair for the main that loops Morton Taylor to Ecorse and Van Born is
      complete. We moved the hydrant from median to behind Mike's Kitchen for DDA
      Pedestrian walkway project. GLWA pump stations are sending higher pressures to our
      area but our pressure reducing valves have kept it from damaging the mains and
      causing main breaks and water hammer.
- 2. Administrative Reports Director Taylor
  - a. GLWA Contract Re-opener- We have begun our five-year contract negotiations with GLWA. The process involves reviewing usage histories and other factors to keep rates and cost down. Another meeting is set for November 2, 2017.

- b. GLWA one Water Agreement- The new partnering agreement was established and signed by GLWA stakeholders on September 28, 2017.
- 3. Asset Management Presentation- Maria Sedki (Fishbeck, Thompson, Carr & Huber)

Ms. Sedki gave a presentation of the SAW grant. What it is and how it can be used within the grantees system. Some key points were; SAW stands for Storm Water, Asset Management and Waste Water. The Township applied for a SAW grant and was the granted \$777,777. The grant can be used to improve or maintain the Sanitary Sewer System, or to install or maintain a Sanitary System asset management program itself. The grant pays for a wide array of items within those group including Engineering, planning, labor cost, supplies and management of.
