INFLATABLE USE GUIDELINES

Due to limited electricity, it is suggested that inflatable companies provide a generator in case it is needed.

As responsible party for the operation and use of an inflatable ride on the property of the Charter Township of Van Buren, the above organization agrees to closely follow the manufacturer's instructions and guidelines for operation and setup.

Additionally, the above organization agrees to follow the recommendations developed by the Consumer Products Safety Commission for inflatable rides listed below:

- Minimum number of operators is TWO (2) on a large slide over 15 feet tall.
- Minimum number on an inflatable small slide or other inflatable, under 15 feet, is ONE (1).
- Maximum recommended weight per passenger is 200 lbs., or per manufacturer's recommendation.
- Do not exceed manufacturer's requirements for maximum loads for individual rides.
- Follow the owner/operators manual for site layout, inflation procedures, ropes, tethers, tie downs, anchors, use temperature range, maximum number of riders, size of riders, electrical codes, daily operation, daily inspection, washing, repair, deflation, drying, storage, and transportation.
- **MOON BOUNCES ARE PROHIBITED.**

CERTIFICATE OF INSURANCE & RELEASE OF LIABILITY REQUIREMENTS

The sponsoring agency of an amusement activity shall provide the Van Buren Township Parks and Recreation Department a Certificate of Insurance as follows:

COVERAGES Comprehensive General Liability- Bodily Injury and Property Damage

LIMITS \$1,000,000 Combine single limit – each occurrence and aggregate

In addition, the certificate **MUST** indicate that the Charter Township of Van Buren, its elected officials, employees and volunteers, and others working on behalf of the Charter Township of Van Buren are named as "Additional Insured" and shall hold them harmless from any and all loss, damages, liability, claims, actions, suits, proceedings of every kind or character arising out of injury, including death, to persons or damage to property due in whole or in part as it relates to the sponsored event. **The specific name and date of the event must be detailed on the certificate, as well as the name of the Park where the event will be held.** It is understood and agreed by naming the Member as additional insured, coverage afforded is considered to be primary and any other insurance the Member may have in effect shall be considered secondary and/or excess.

Certificate of Insurance MUST be delivered to the Parks and Recreation Department no less than two (2) weeks before the activity.

RELEASE OF LIABILITY

To the fullest extent permitted by law, the above organization agrees to defend, pay on behalf of, indemnify, and hold harmless the Charter Township of Van Buren, its elected and appointed officials, employees and volunteers, and others working on behalf of the Charter Township of Van Buren against any and all claims, demands, suits, or loss, including all costs connected therewith, and for any damages which may be asserted, claimed, or recovered against or from the Charter Township of Van Buren by reason of personal injury, including bodily injury or death and/or property damage, including loss of use thereof, which arises out of, or is in any way connected or associated with the sponsoring organization's amusement activity.
